


Series WFTC F&T Cover Assembly Repair Kit

Installation Instructions



Installation

1. Close supply and return side valves and let steam trap cool.
2. Remove bolts (A) wire brush clean if needed, and put aside.
3. Remove existing cover assembly and discard. Remove old cover gasket and discard. Make sure that the body flange is clean and all remnants of the old gasket are scraped off. Trap body (D) stays attached to the system piping. Clean out any sludge/debris from inside the trap body.
4. Install new cover assembly (B) with new cover gasket (C), making sure port (E) lines up with similar port in the gasket and trap body. Reinstall original bolts and torque between 25-40 ft - lbs.
5. Slowly open supply valve, then slowly open return side valve. Check and retorque bolts after the trap is at operating temperature.
